# **Support Services**

#### **Welcome Center**

Take advantage of our in-person services in the Welcome Center for assistance with all of your financial aid needs. From the application process to navigating the world of financial aid and scholarships, SFS is ready to assist you. Visit the lobby desk in the Welcome Center and you'll be directed to our front counter.



# **Online Services**

ConexED is a platform that allows students to connect with departments and services online, regardless of your physical location. With ConexEd, you can drop in to virtual offices, make appointments, send messages and ask important questions to the SFS team. Sign in to ConexED using your student email and password.

# **SFS Counselors**

Are you considering withdrawing from a course or are in danger of not passing a course? Have you received a financial aid warning email? Have you received a financial aid ineligible email? Need to create or update your Student Educational Plan (SEP)? Schedule an appointment with an SFS Counselor.





# **FAFSA**

If you need financial assistance to pay for college, don't miss out! Submit the FAFSA, include Moreno Valley College's school code O41735 on your application, and ensure your social security number is on file with Admissions and Records. Federal and state funds, including grants and

scholarships, remain available for scholars year-round. Submitting the FAFSA is the first step. Check your file status and complete pending actions at the MVC StudentForms financial aid portal and follow up on all requests from SFS.

# CADAA

There are many financial aid options for undocumented/dreamer students. If you are undocumented and have been determined AB 540 eligible by Admissions and Records, submit the California Dream Act Application (CADAA) and include the MVC school code 04173500. CADAA information is private! The CADAA does not link applicant



information to federal government databases. The California Student Aid Commission (CSAC) keeps CADAA applicant data confidential. CADAA data will not be shared with, or disclosed to, any federal agencies, including immigration enforcement.

California has two primary financial aid applications. Students will only submit one or the other, never both.

# Pro Tips For Completing the 2024-2025 FAFSA Form

#### GET A STUDENTAID.GOV ACCOUNT BEFORE STARTING THE FAFSA

Before starting the FAFSA form, you'll need to *create a StudentAid.gov account* to access and fill out the 2024–25 form. Your contributors will each need their own StudentAid.gov account too and should also be created before they enter the FAFSA.

#### **HAVE YOUR DOCUMENTS READY**

Starting with 2024–25 form, you'll be able to provide consent and approval to have most of your financial information imported directly from the IRS, but you should keep your tax return handy for additional questions.

#### HAVE YOUR CONTRIBUTOR INFORMATION READY

To invite contributors to your FAFSA form, you'll be asked to provide their first and last name, SSN (if they have one), date of birth, and email address (or mailing address, if they don't have an SSN). To avoid issues with your FAFSA form, list contributor information exactly as it appears on their Social Security card or legal identification card.

#### THE STUDENT SHOULD COMPLETE YOUR SECTION OF THE FORM FIRST

If you don't start the form first, or if you and your contributors are working in your form at the same time, your contributors may have more difficulty completing their section or may even spend time providing information that's not required. Starting the form first will also prevent data entry mistakes, such as your parent accidentally entering their own information when they should be entering yours. Once you've completed your section, be sure to send invitations to all contributors to your form before saving and exiting.

#### **READ QUESTIONS AND DEFINITIONS CAREFULLY**

There've been major updates to the FAFSA form for the 2024–25 award year, and many questions and definitions have changed. When filling out your form, read each question and definition carefully. \*Click the link above to view some terms that are new or have newly updated definitions for the 2024–25 form.

#### **CONSULT IN-FORM RESOURCES IF YOU NEED HELP**

Use the help text and help articles (accessible via the question mark icon) embedded in the form if you're not sure how to answer a question. Changing your answers to questions that impact your eligibility for aid may create errors in the form. If you change your answer to the Marital Status, Citizenship, State of Legal Residence questions, you may need to delete your form and start over to fix the error.

#### YOU CAN CORRECT YOUR FAFSA MISTAKES

You'll be able to correct the error as soon as your form is processed.



# WebGrants for **Students (WG4S)**

The WebGrants 4 Students (WG4S) portal is to provide students with the resources, information and tools needed to assist with the college financial aid process. (WG4S) will allow you to manage your Cal Grant and/or Chafee account(s) online by letting you view updates, make school changes, make address changes, and post leave of absence requests. Note: your WG4S account does not replace your School or FAFSA accounts. Each account must be monitored and managed independently.

Students should monitor their WebGrants 4 Students portal to confirm their award status for the Cal Grant and the Chafee Grant for foster youth. Follow the links to *Create Your* Account and Accessing and Navigating WG4S.

# TO-DO LIST 🗹



- Check your award status and award amount.
- · Verify if there are any pending items or forms that still need to be completed.
- Confirm that your school of attendance is MVC. This refers to the college you plan to attend, not your high school.
- Verify that your GPA was received.
- Verify your high school graduation date. This will become available on the 1st day of the month of your planned graduation.
- Students with Dependents can certify your eligibility.
- Chafee Grant recipients can check that your "Department of Social Services Record" is complete to verify your foster youth status.



# Cal Grant Access Awards

# Students With Dependent Children (SWD)

The Students with Dependent Children (SWD) Grant increases the Cal Grant award by up to \$6,000 for qualifying Cal Grant B recipients and up to \$4,000 for qualifying Cal Grant C recipients.

To qualify, the student must have dependent children under 18 years of age for whom they provide more than half of their financial support during the academic year and indicate they have a child/children on their FAFSA or CADAA. About a week after submitting your application, log in to your *WebGrants for Students account* to self-certify your dependent children to complete the certification for your award.



# Cal Grant B for Foster Youth

This access award provides current and former foster youth increased Cal Grant eligibility of up to \$6,000 per year, renewal for the equivalent of eight years of full-time attendance in an undergraduate program, they have until age 26 to apply for the Cal Grant High School Entitlement Award, and they can apply for a High School Entitlement award through September 2, at a California Community College. Students can receive this access award in addition to the Chafee Grant.



# 24-25 Program Update

The California Student Aid Commission (CSAC) announced significant changes to the state's Chafee Grant Program. Starting in the 2024-25 academic year, Chafee Education and Training Vouchers will no longer be treated as "other financial assistance" or be counted against the cap on how much financial aid a student can receive. This change will enable eligible Chafee Grant recipients to access the full \$5,000 award amount and, in some instances, receive a total financial aid package that exceeds their Cost of Attendance.



# Student Success Completion Grant (SSCG)

The Student Success Completion Grant is administered by the California Community Colleges and provides a grant award to students that are enrolled in 12 or more units, receive the Cal Grant B or C, and are California residents or meet the requirements for a non-resident tuition exemption. Students must also meet Satisfactory Academic Progress (SAP) standards to receive the SSCG.

Eligibility for non-foster students:

- Students enrolled in at least 12 but fewer than 15 semester units receive **\$1298 per semester** (\$2596 annually).
- Students enrolled in 15 or more semester units receive **\$4,000 per semester** (\$8,000 annually).

# **SSCG** Increase for Foster Youth

SB 117 increased the grant amount for current and former foster youth beginning with the 2023-2024 academic year. Current and former foster youth is defined as a person whose dependency was established or continued on or after the age of 13. Current and former foster youth students enrolled in 12 or more units receive \$5,250 per semester.

# CAL GRANT PRIORITY DEADLINE EXTENSION

The Department of Education has announced that due to the later than usual FAFSA and CADAA release date, the Cal Grant priority application deadline has been extended from March 2, 2024 to May 2, 2024. This change will allow students additional time to submit their FAFSA's and ensure their GPA has been submitted for 2024-25 Cal Grant consideration.

# The California Dream Act Service Incentive Grant (DSIG)

This program encourages CADAA students that have been awarded a Cal Grant A or B, to participate in a community or volunteer service activity. The California Student Aid Commission (CSAC) will award up to \$4,500 per academic year (up to \$2,250 per semester) to eligible students, after completing 150 service hours per semester (a total of 300 service hours from July 1 through June 30).

Eligible students must maintain Satisfactory
Academic Progress standards, demonstrate sufficient
financial need, be enrolled at least half-time, and
complete any necessary verification for their Cal
Grant A or B award. Applicant's should review the

# Free Legal Assistance for MVC Dreamers

The Perris-based legal center provides local residents with free DACA renewal application, legal and USCIS fee help.

Take advantage of their free services by filling out the online application form. A TODEC staff member will follow up with your request. You will receive a telephone call from their scheduling department 1 to 4 business days after your request is received, excluding Holidays observed and Weekends Support is available in both English and Spanish.



# Public Benefit Finder for California Students

# Accessing Vital Documents for Youth Experiencing Homelessness

If you were born in California, find out how you can access your free birth certificate and ID, if any one of these situations applies to you:

You are staying in a home that is not yours, your parent's or legal guardian's because you had to leave your home.

You are in an unstable living situation, without a safe or steady home.

You are sleeping in a motel, car, tent, abandoned building, or public place.

You are staying in a shelter or transitional living program.





# Need a birth certificate or ID for free?

California state laws give children and youth experiencing homelessness the right to get their birth certificates and IDs at no cost and without the signature of a parent or guardian.



# Foundation Scholarship Update

Foundation Scholarship offers for 2024-25 will be announced late May. Be sure to log into the scholarship site promptly to accept scholarship offers. Recipients will begin receiving disbursements in the 2024 fall term.

# **Scholarships**

MVC encourages all students to regularly apply for scholarships to help ease the financial burden of attending college. Scholarships are financial aid awards designed to help you pay for your education. Scholarships can be a one-time award or renewable and may require that certain academic or demographic qualifications be met.

# Dependency and EFC Appeals

SFS Consumer Guide

If you are unable to provide parent information on the 2024-2025 financial aid application, contact SFS at MVC to discuss your options. Students with unusual circumstances that prevent them from providing parent information will benefit from the simplified questions on the 2024-2025 FAFSA that more efficiently determine their independent status. Students who indicate unusual circumstances on their FAFSA form will

be granted provisionally independent status and will need to follow up with a financial aid administrator at MVC. The final determination of a student's dependency status will be evaluated based on an appeal submitted with official supporting documentation provided by the student, or a financial aid administrator may perform their own personal assessment.

A student cannot be determined to be independent for the following reasons: parents do not want to provide information on the FAFSA/CADAA due to privacy concerns, parents do not feel it is their responsibility to provide financial assistance for college, parents no longer claim you as a dependent on their taxes, or you are self-supporting and/or no longer live with your parents.

An EFC Appeal is also an option for students that have had a drastic change in income due to an unforeseen or special circumstance. If you feel you may qualify to have your income re-evaluated based on a more recent year, contact SFS to discuss your options.

# **Understanding Tax Credits**

Did you know that by simply filing your taxes, you may be eligible to unlock thousands of dollars in state and federal tax credits? Tax credits reduce the amount of tax you owe, and depending on the tax credit, may give you cash back even if you don't owe any taxes or earned any income. Whether you're filing your taxes online on your own, with virtual help, or with in-person help, you may be eligible to receive multiple tax credits — so make sure you file both your state and federal tax returns for the 2023 tax year by the April 15, 2024, deadline to maximize your money back this year!

Here are some tax credits you may qualify for:

- Earned Income Tax Credit (EITC)
- CA Earned Income Tax Credit (CalEITC)
- Child Tax Credit (CTC)
- Young Child Tax Credit (YCTC)

- Foster Youth Tax Credit (FYTC)
- Nonrefundable Renter's Credit
- Child and/or Dependent Care
- and more!



# **Understanding Satisfactory Academic Progress (SAP)**

SAP REQUIREMENTS AND FINANCIAL AID ELIGIBILITY



To remain eligible for financial aid, you must meet the minimum cumulative GPA requirement.



You must, at a minimum, receive satisfactory grades in 67% of cumulative credits attempted.



You must complete your program of study before attempting 150% of the credits required for your program.

SAP STATUSES



# **SATISFACTORY**

You meet all requirements and are eligible for financial aid.

Keep up the good work!



#### WARNING

You haven't met one or more requirements for one term.
You're eligible for aid but you must meet all requirements by the end of the next term.



#### **INELIGIBLE**

You haven't met requirements for two consecutive terms and are no longer eligible. You may appeal to reinstate your financial aid.

# **TAKE ACTION**

- Strive for a grade of C or better in all of your courses.
- Before you drop a class, check with Student Services.
- Maintain good study habits and continue towards your goal!

## **TAKE ACTION**

- Evaluate what is preventing you from meeting academic requirements.
- Take advantage of your resources and visit with your instructors, financial aid, counseling, and tutorial services.

## **TAKE ACTION**

- File a SAP Appeal through your financial aid portal at StudentForms.
- Meet with a Student Financial Services Counselor.
- Speak with Student Financial Services for assistance.
