**PLEASE BRING PHOTO ID AND LIVE SCAN APPLICATION.** Examples of valid ID are: State Driver's License or State-issued ID, Military Card, Passport, or Alien Registration Card (green card).

\*\*\* All agencies charge a non-refundable rolling fee for Live Scan. The Department of Justice Firearms Division charges a submission fee of \$32.00 and the FBI charges a \$19.00 firearms fee. The total charge will be the agency rolling fee plus the DOJ submission fee and FBI firearms fee. It will be charged at the Live Scan location. *Fees may change without notice.*
